In 1974, five community-minded people came together to form the Shiawassee Community Foundation. They started with \$5 and the goal of improving life for people in Shiawassee County. As a 501c3 charitable non-profit, the Foundation has since grown to manage over 100 funds totaling more than \$12 million. SCF currently employs three staff members who are overseen by a Board of Directors.

The Shiawassee Community Foundation also supports a Youth Advisory Council (YAC) that was founded in 1995 through an endowment from the W.K. Kellogg Foundation. The YAC is comprised of community-focused students aged 12-21 from the Shiawassee area. YAC empowers youth to make an impact and become young philanthropists through volunteerism and involvement in the grant-making process.

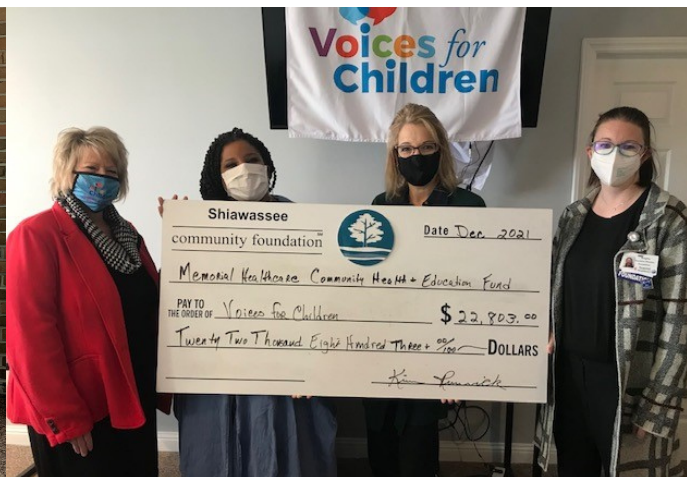
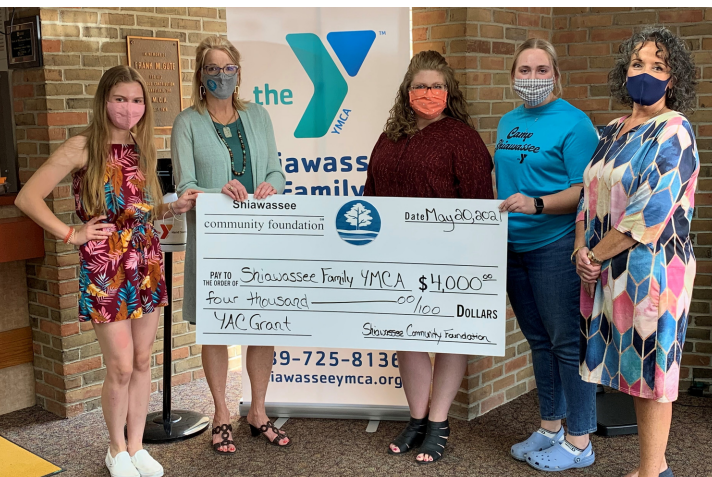

2021 SCHOLARSHIPS



The Shiawassee Community Foundation has nearly 100 scholarships available to area students! The application is open annually, October-January, to high school seniors, 5th year, returning college students, and non-traditional students. These funds can be used for certificates and two- or four-year programs at colleges, universities, trade, or vocational schools!

In 2021, Shiawassee Community Foundation adapted yet again to honor the 2021 scholarship recipients. A virtual awards ceremony was held via YouTube and included many of the board members as well as staff. The ceremony acknowledged the 134 scholarship awards totaling \$149,586.



In addition to the academic scholarships through the Foundation, there are scholarships available for band or music camp, FFA programs, and golf.

William "Bill" J. Brooks Memorial Fund

The family of William "Bill" J. Brooks established a memorial fund in his name with the Shiawassee Community Foundation. This fund was made to honor the legacy of U.S. Navy Veteran, Bill Brooks, who after traveling the world with his wife Heather, returned to live in his hometown of Owosso. He built a life here with his wife and their daughter, Cheyenne. The beautification of the Owosso community is something that Bill put his heart and hard work into.

In his memory, this fund will be awarded as a grant to non-profits in Shiawassee County for community beautification projects. This could include, but is not limited to, tree and flower planting, community gardens, upkeep/repair of downtown projects, parks, and community spaces, as well as plant and tree education/camps/classes for any age.

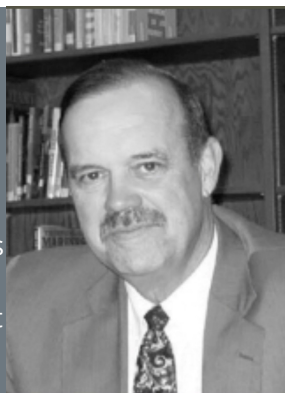
Carl E. Voorhies and Kathryn D. (Kate) Voorhies Memorial Endowed Scholarship

The fund was established at the Shiawassee Community Foundation in March 2021 by Byron Community Schools. This endowment fund was established in memory of Carl E. Voorhies and Kathryn D. (Kate) Voorhies.

Carl and Kate originally bestowed a portion of their estate to Byron Community Schools. The funds were then transferred to the Shiawassee Community Foundation to create a scholarship for students who are current seniors or have graduated from Byron High School in the past two years. Preference is given to a student who resides in Gaines, who is pursuing post-secondary education including college, university, or trade school, with a priority given to students studying in an animal science field.

Dr. Mark Miller Memorial Scholarship

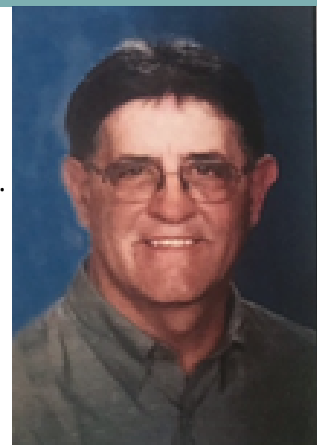
Dr. Mark Miller, long time Shiawassee County area educational administrator, passed away in April 2021. Dr. Miller, taught math, science, and physical education at the elementary and middle school levels; coached at the middle school, JV, and varsity levels and also served as an administrator. Dr. Miller was an Elementary Principal, Academically Talented Coordinator, Curriculum Director and State/ Federal Grant Director, Assistant Superintendent and Superintendent. He dedicated much of his life serving the community sitting on numerous boards and committees at the local, county, and state levels including service on the Shiawassee Community Foundation board from 2003-2012, serving as president in 2008.



Mark left behind his wife Jimsey, daughter Amy and her husband Nick Holek, and beloved grandchildren Miller and Emme Lantis and Raegan and Brock Holek. The family has set up a scholarship fund with the Shiawassee Community Foundation. The scholarship is available to Byron or Corunna high school seniors and graduates attending a 4-year accredited college. Student grade point average must be above a 4.0, be a member of National Honor Society, and participate in at least two extracurricular activities, ex: sports, band, FFA, student council, etc.

Andrew Osika Memorial Scholarship

The Andrew Osika Memorial Scholarship was established in 2020 by his wife Teresa and memorials from family and friends to honor Andrew "Andy" Osika. Andy passed away suddenly, July of 2020, doing what he loved to do, driving his tractor down the road between the farm fields where he grew up. He was married to his wife Teresa for over 39 years and together they raised two children. Andy was a proud farmer and though he had worked at other jobs over the years, his first love was farming. He had a generous heart, was a hard worker and was always happy to help others, especially his farming friends.



This scholarship will be available to seniors and graduates of a Shiawassee County area high school who want to pursue a career in the agriculture field. Preference will be given to Corunna High School seniors and graduates. The recipient of this scholarship must be a member of FFA or 4-H. Financial need will be considered.

 - Talk to the Shiawassee Community Foundation and your professional advisor to learn about all the options that match your giving interests for the community. You can customize a Fund Agreement that will become active once the Foundation receives funds from your estate.
